



# Peak Season Surcharge

Effective October 4, 2024, and November 1, 2024, through January 13, 2025

## Tire Peak Season Surcharge - Effective Oct 4, 2024

Effective October 4, 2024 Canpar Express will be implementing a Peak Season Tire Delivery Fee of \$20 per piece. This commodity specific fee will be applied in combination to existing Extra Care fees that are generally applicable. This seasonal surcharge will remain in effect until January 13, 2025.

## Special Handling Peak Season Surcharges - Effective October 4, 2024 & November 1, 2024

Effective October 4, 2024 (For USA & International Accessorial Surcharges) and November 1, 2024 for Domestic Accessorial Surcharges, Canpar Express will be implementing Peak Season surcharges on applicable Special Handling Fees as detailed in the table below. These seasonal fees will be charged in combination with existing fees. This seasonal surcharge will remain in effect until January 13, 2025.

## Residential Peak Season Surcharge - Effective November 1, 2024

Effective November 1, 2024 to January 13, 2025, a residential peak surcharge of \$2.00 per shipment may apply to customers that ship more than 2,000 residential shipments per business day or 10,000 residential shipments per week, in any week during the months of November and December 2024. This charge will only apply to volume that surpasses 200% of the customer's weekly average as measured between June 2, to June 30, 2024 and where expressed written consent for the increase was not provided by *Canpar Express*. Once applied, the Residential Peak Surcharge will apply to residential shipments as determined by *Canpar Express* in its sole discretion for the duration of Peak Season.
